In an automated world everything is big-data driven therefore, it is of necessity that there is adequate regulation and growth of sound jurisprudence on data protection law. Interestingly, India is a new member to the family of privacy rights, it was in 2017 that India recognized privacy as a fundamental right (K.S. Puttaswamy-I). However, data protection continues to be a facet still to be recognized as a fundamental right. The newly enacted Personal Digital Data Protection Act, 2023 is the prime legislation for governing the matters of data protection law in India. The coming of the enactment has created new legislative entities in the form of Data Protection Authority, Appellate Tribunal and will also create positions of Data Protection Officer at Data-Fiduciary level. With the nascent origin of data protection legislation, and thousands of Data-Driven companies working in India, there would be a large demand for Data Protection Officer in coming times. Further the recent cases of privacy breach and challenge to data protection regime needs to be analyzed from the point of views of different legal regimes, to have better understanding and insight into the data protection legal regime.

LEARNING OUTCOMES, EVALUATION & CERTIFICATION

The Individual undergoing the course will be able to:

- Differentiate between different forms of privacy regulations.
- Understand the standard rules on Data Protection Compliance

There would be weekly evaluation of the participants, consisting of Quizzes and assignment-based evaluation. SYLLABUS

I. INTRODUCTION TO LAW OF PRIVACY & INDIAN CONSTITUTION

Module I of the course would be dealing with introduction to law of privacy, the hierarchies of the legal system, the basis of Indian Constitution, introduction to privacy rights and its segregation from data protection law. Further, the module will analyze the ‘dignity-based’ approach adopted under the Indian Constitution for the recognition of privacy as a fundamental right. And how a dignity-based approach draws an inspiration from European & American jurisprudence. A study of chronological judgments which have established privacy as a normative value among Indian Constitution would be studied and how it led to the origin of Data Privacy jurisprudence.

II. INTRODUCTION TO THE CONCEPT OF INFORMATIONAL PRIVACY & A GENERAL INTRODUCTION TO DPDP ACT, 2023

Module II will be specifically dealing with the origin of data protection jurisprudence and how the data protection jurisprudence is a separate norm from the privacy rights. The module will also deal with the idea of ‘data ownership’? The Kind of challenges that data breach produces for privacy rights i.e., algorithm tracking, data profiling and data mining. The module will also introduce the learner to the basic concepts surrounding data protection.

III. DATA PROTECTION DEFINITION CLAUSE

Module III will be dealing with definition clause. The module will explain the technical jargon of personal data protection such as personal data, anonymized data, pseudonymized data, data profiling, data principal, data fiduciary, data controller, data subject, data processor, data protection officer, consent manager, personal data breach, data processing. The scope and approach of the Digital Personal Data Protection Act, 2023. The European Approach in determining personal data, the U.S. Approach for determining personal data.

IV.&V. DATA PROTECTION COMPLIANCE REQUIREMENTS

Module IV & V will be dealing with compliance requirement under the novel Digital Personal Data Protection Act, 2023. Additionally, the modules will also discuss some of the best practices in data protection regime in India, Europe and United States. What does an idea of Data Protection Impact Assessment means? What are the different mechanisms of ensuring that free flow and integrity of the personal data is maintained.

VI. DATA PRINCIPAL RIGHTS

With the upcoming of the Digital Personal Data Protection Act, 2023 there will be collateral addition of personal data protection rights. As the objective of the Personal Data Protection is to empower the individual against the possible breaches of personal data by State and Non-State entities. Personal Data Protection rights play a major role as an enabler or to be precise as a bargaining tool for an individual against giant corporations and even State. The Module will be discussing some of the mainstream rights, such as: Right to Erasure/Right to be Forgotten, Right to Object, Right to Portability, Right to Object and many more.

VII. TRAINING SESSION FOR DATA PROTECTION OFFICER

The seventh module will be a training session for participants, as the new data protection legislation is going to create a lot of demand for the position of 'Data Protection Officer'. The seventh module will be an exercise cum lecture model for inculcating within the participants the skill set required for performing the task of a Data Protection Officer.
