- 4. It is needless to state that the CEC will give hearing to all the stake holders, including the State Government and the writ petitioner before the High Court.
- 5. List on 12.11.2025 high up on the Board.
- 6. In the meantime, the petitioner-State is directed to maintain *status quo* as on today in respect of the areas which are directed to be notified as tiger reserve by the High Court.
